### 1. Infrastructure – Investments in Municipal Infrastructure

1.1 Ensure that existing infrastructure is sustained reflective of the Asset Management Plan

- Maintain a ten-year capital forecast to be reviewed annually.
- Review the asset management plan annually.
- Be prepared for future infrastructure funding.
- Create a Long-Term Financial Plan

#### 2019 Approved Actions

- Adopt an Asset Management Policy
- Identify three top priority projects. (annually)
- Update the Roads Need Study
- Obtain a Staff Report regarding removeable speed bumps
- Complete resurfacing of McFadden road system
- Upon completion of the Roads Needs Study, update the Roads Standards by-law, reviewing discrepancies and level of service
- Address vacancy / future use of the previous bank space at 135 Burleigh St. (while maintaining the RBC ATM in Apsley)
- Review the infrastructure / renovation requirements of the Health Centre

1.2 Plan infrastructure development with Demographic Needs.

- Continue to pursue opportunities to widen County and Municipal Roads to support safe usage.
- Investigate partnership and funding opportunities with both the private and public sector to assist with infrastructure maintenance and expansion.

#### 2019 Approved Actions

- Complete a lake tour – suggestions include N. shore of Stony, Chandos and Jack Lake, possibly three separate tours
- Review municipal surplus property
- Investigate sidewalk installation on McFadden, proximity to NKCC and to town  
Apply for the ICIP Rural and Northern grant opportunity for Mt. Julian / Viamede Road.

1.3 Explore complete communities / street scaping.

#### 2019 Approved Actions

- Analyze demographic information and trends.
- Investigate a downtown master plan (open houses, public consultation)
- Determine the project list for the Main Street Revitalization funding

## 2. Economy - Guide Economic Growth for a Sustainable Community

### 2.1 Implement the Community Improvement Plan (CIP)

- Identify CIP programs annually

#### 2019 Approved Actions

- Appoint a Community Improvement Plan (CIP) Committee with approved Terms of Reference
- Proceed to approve CIP programs and funding for 2019
- Consider funding options for design façade and streetscaping

### 2.2 Develop an Economic Development Strategic Plan

- Support a strong, sustainable economy.

#### 2019 Approved Actions

- Collaborate with OMAFRA to complete the Economic Strategic Plan
- Consider open houses / consultation process.  
Complete OMAFRA's First Impressions Community Exchange (FICE)
- Consider implementing OMAFRA's Business Retention and Expansion Program or other business retention strategies
- Collaborate with Kawartha Chamber of Commerce
- Collaborate with Peterborough and the Kawarthas Economic Development to identify local economy
- Develop mechanism(s) to encourage public input regarding economic development
- Appoint liaison to the Economic Development Cooperative
- Review Phase II of the Wayfinding project (with PKED Tourism)
- Explore methods to support local business i.e. contractors for building
- Investigate Uber / taxi and other transportation options.

### 3. Governance – Maintain a Strong, Accountable Municipal Government

#### 3.1 Maintain policies that enable effective governance.

##### 2019 Approved Actions

- Identify policies that Council is accountable for and schedule reviews.
- Participate in the County of Peterborough and North Kawartha's Official Plan review.

#### 3.2 Provide Quality Community Programs and Services

- Continue to seek opportunities to enhance active lifestyles.
- Advocate for the sustainability of Health Services and Programs.
- Advocate for affordability and safety in policing.
- Advocate against / discourage provincial downloading and changes to regulatory framework without consultation.

##### 2019 Approved Actions

- Continue to review current speed limits on roads within the Township. Prioritize the roads.
- Investigate the establishment of year-round multi-use pathways / trails.
- Monitor the development of the Kawartha Highlands Provincial Park Interpretive Trail.
- Explore opportunities to identify and support vulnerable sector populations in the Community.
- Review the capacity requirements of the Health Centre
- Collaborate with partners and prepare the legislated Community Safety and Wellbeing Plan
- Meet with the Ministry of Transportation in regards to the Highway 28 corridor in North Kawartha
- Enter into a Memorandum of Understanding (MOU) with the Library
- Enter into a Memorandum of Understanding (MOU) with the Apsley & District Lions regarding the Lions Park
- Support the revitalization of the Lions Park

#### 3.3 Provide for effective Township Communications.

- Determine communication objectives and identify target audiences
- Provide for an effective Township Public Relations Program

##### 2019 Approved Actions

- Monitor and improve audio / visual recording systems. (consider one microphone per person, permanent wiring)
- Review the value of information being published to website subscribers and improve content



## 4. Environment – Protect and Enhance Environment

### 4.1 Promote Responsible Environmental Stewardship

- Protect our lakes and local watersheds, including Eels Creek
- Support the education of the public in regards to protecting and preserving our natural environment

#### 2019 Approved Actions

- Continue to review data and expand knowledge of issues impacting our lakes and watersheds.
- Investigate a tree by-law or other ways to require natural vegetation and avoid clear cutting eg. % naturalized shoreline, trim trees at bottom,
- Investigate grant opportunities for flood mapping in North Kawartha
- Invite local groups to present to Council regarding invasive species and other lake concerns.

### 4.2 Protect the human environment.

- Initiate a Community Master Plan to improve the human environment
- Address safety issues on Burleigh Street.

#### 2019 Approved Actions

- Determine use of the Main Street Revitalization grant
- Continue to investigate sidewalks in the hamlets
- Attend the Community Development Committee as a partner.
- Investigate affordable housing options.
