

Notice of Nomination for Office in the Township of North Kawartha

Municipal Elections Act, 1996 (s.32)

Notice is hereby given to the Municipal Electors of the Township of North Kawartha that Nominations in the Township of North Kawartha for the offices of:

Mayor; Deputy Mayor; Councillor At Large (one for each office to be elected at large)

Councillor Ward 1 (Chandos) (one for office elected by Ward 1 electors)

Councillor Ward 2 (Burleigh-Anstruther) (one for office elected by Ward 2 electors)

may be made by completing and filing in the office of the Clerk, nominations on the prescribed form and accompanied by the prescribed nomination filing fee of \$200.00 for the Head of Council and \$100 for all other offices. The filing fee is payable by cash, debit, certified cheque or money order.

A Candidate is entitled to receive a refund of the nomination filing fee if the documents required under subsection 88.25 (1) of the Municipal Elections Act are filed on or before 2:00 p.m. on the filing date in accordance with that subsection.

A nomination must be signed by the candidate and may be filed in person or by an agent during regular business hours (9:00 a.m. to 4:30 p.m.) between May 1, 2018 and July 26, 2018, and between 9 a.m. and 2 p.m. on **July 27, 2018 (Nomination Day)**.

A nomination for council must also include endorsement signatures from at least twenty-five (25) persons who are eligible to vote in an election within the municipality where a nomination is being submitted.

Registration papers for third party advertisers must be signed by a representative and may be filed in the Office of the Clerk in person or by any agent during regular business hours from May 1, 2018, up to and including October 19, 2018. Registration papers along with a Declaration of Qualification must be certified by the Clerk before such entity becomes a Certified Third Party Advertiser.

In the event there are an insufficient number of certified candidates to fill all positions available, nominations will be reopened for the vacant positions only on Wednesday, August 1, 2018, between the hours of 9 a.m. and 2 p.m. and such additional nominations, if required, may be filed in the office of the Clerk.

Electors are hereby given notice that if a greater number of candidates are certified than are required to fill the said offices, **voting by internet or phone** will be opened at 10:00 a.m. on October 9th to 8:00 p.m. on October 22nd, 2018.
