Notice of Statutory Public Meeting for an Amendment to the Township's Comprehensive Zoning By-Law #26-2013

The Council of the Corporation of the Township of North Kawartha will be holding a public meeting of Council for the purpose of obtaining public comments with respect to a series of proposed changes to the Township of North Kawartha Comprehensive Zoning By-law 26-2013.

If you wish to participate in the electronic meeting in real time, please contact the [Deputy Clerk](#) by email no later than 4:00 p.m. on the day prior to the scheduled meeting and you will be provided with an invitation to join the meeting using your computer or phone. Although possible for members of the public to “attend” a meeting electronically, and provide verbal submissions, we would encourage you to communicate with Council by forwarding written comments in support or opposition to planning@northkawartha.ca.

The Township is using Zoom for electronic meetings. Recorded meetings will be posted on the Township [YouTube](#) channel as soon as possible after the meeting for public viewing.

Purpose and Effect

The following is a summary of the changes proposed through the draft amendment:

- Amending definition for “Tourist Trailer”;
- Allowing for use of tourist trailers and tourist vehicles in residential zones and in the rural zone; and
- Adding general regulations for the use of tourist trailers and tourist vehicles.

A copy of the draft amendment as well as the consolidated text of the proposed zoning by-law can be obtained from the Township of North Kawartha website and is available for inspection at the Township of North Kawartha Planning Department during regular office hours.

Lands Affected

The proposed amendment is a text only amendment and therefore a key map has not been provided.

The Right to Appeal

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Corporation of the Township of North Kawartha to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of North Kawartha before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or a public body does not make oral submissions at a public meeting, or make written submissions to the Township of North Kawartha before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

As per Ontario Regulation 149/20, the final day to appeal the decision will be 20 days after the date of the notice of decision following the termination of the COVID-19 emergency.
