# Township of North Kawartha Corporate Health & Safety Policy for Reduced Fragrances and Scents

#### **Policy Statement:**

Everyone should have safe and healthy places in which to live and work. The use of scented products has an impact on air quality. Some people react adversely to some scents and fragrances creating health concerns.

#### **Definitions:**

"Fragrance" means any ingredient that is deliberately added to a product to impart a scent or mask a scent.

"Scent" means any odour released from a manufactured product. Examples of potential scented products in the workplace are carpet glue, cleaning products, cologne, perfume, deodorants and paints.

#### Hazards:

Increasingly people are becoming sensitized to chemicals emanated from fragrances and perfumes which for some people pose a serious health risk.

The potential impact of these chemicals on human health is magnified because many people spend much of their time indoors or in vehicles. Most people on a daily basis use soap, shampoo, deodorant, laundry products, hair spray, lotions, cosmetics and fragrances which are known to be triggers for asthma, allergies and migraines. Even people that do not have pre-existing health problems can have an irritation to their upper airways or eye symptoms.

#### Are some people more vulnerable to fragrances than others are?

Some people have become very sensitive to certain chemicals because of past exposures. They can suffer a wide range of health effects such as rashes, severe headaches, breathing difficulties, nausea, dizziness and fatigue, whenever they are exposed to even very low levels of these chemicals in the fragrance.

#### **Hazard Control:**

Council Members and Employees are asked to eliminate or reduce the use of fragrances or scents in the workplace.

While we operate public facilities, the promoting of scent reduction in the workplace must include the public as well as employees.

**Enforcement:** The Head of Council, the Chief Administrative Officer and Department Heads are responsible for enforcing this policy.

#### Chief Administrative Officer and Department Heads meet this standard by:

- Ensuring council members, employees and the public are made aware of the
  policy and practice to eliminate or reduce the use of fragrances or scents in the
  workplace.
- Ensuring a best effort is made to purchase products or chemicals that are non-fragrant or have reduced fragrances.
- Ensuring municipal facilities/buildings and workplaces display the attached poster.
- Including notification on meeting agendas and public events as follows:
   "The Township of North Kawartha Promotes Scent Reduced Meetings and Events"
- Responding to fragrance and scent related concerns to minimize worker discomfort.
- Working to resolve conflicts as they arise.

#### **Employees meet this standard by:**

- Reviewing information on fragrances and scents in the workplace and eliminating or minimizing the use of fragrances or scents.
- Reporting to their supervisor if they have any health concerns due to exposure to fragrances or scents.

All council members and employees should respond in an understanding and positive manner when asked to limit or eliminate the use of a fragrance.

What do you do when a co-worker is wearing a fragrance that is causing you problems? (i.e. headache, trouble breathing, running eyes/nose, nausea etc.) You may approach your co-worker in a positive manner and share your concerns about the fragrance he or she is wearing in the workplace. Express to your co-worker how their wearing fragrance in the workplace is affecting your health. Cooperation, understanding and respect for each other are the solutions to resolving the problem.

### What if approaching a co-worker about not wearing a fragrance into the workplace doesn't work?


Talk to your supervisor about your concerns. Explain to your supervisor what you have done to try to resolve the issue.

#### What if I am approached about the fragrance I am wearing?

It is okay to feel surprised and taken back. Listen to your co-worker in a non-defensive way. Listen to the problems that the fragrance is producing on his/her health. Discuss your co-workers concerns about the fragrance. Ask questions such as; is it the amount? Is it the type? Be willing to reach a resolution in a cooperative manner.
