Subject: Draft Proposed Cemetery Grant Policy

#### Recommendation:

That Council pass a by-law at the end of the meeting to adopt the Cemetery Grant Policy pending any recommended revisions; and further that Council consider providing funds in the 2026 budget to support non-municipal owned cemeteries.

## **Background:**

In accordance with Section 5 (3) of the Funeral Burial and Cremations Services Act (FBCSA) a cemetery operator shall ensure that the cemetery is operated in accordance with this Act and the regulations and shall ensure that, (b) cemetery grounds, including all lots, structures and markers, are maintained to ensure the safety of the public and to preserve the dignity of the cemetery.

The Township of North Kawartha is the licence holder of ten (10) municipal cemeteries. Only one of these cemeteries is an active cemetery and is maintained by a Community Board. Two municipal cemeteries benefit from regular maintenance. Despite best efforts one municipal cemetery has not been located. The remaining cemeteries tend to receive maintenance as needed.

The Township is required to submit a report on municipal cemeteries at the end of each year to the Bereavement Authority of Ontario. The municipality has a care and maintenance account which at the end of 2024 amounted to \$1,335.32. The total income received in 2024 was \$5.19. Only the income may be used for the care and maintenance of cemeteries. Traditionally the Township has budgeted for maintenance of cemeteries as the necessity arises, such as repairs or replacement of a fence, tree removal and clean-up of downed trees.

On occasion over the years requests have been received from non-municipal owned cemeteries for funds to assist with the care and maintenance of the cemetery.

Traditionally these requests have been denied as the Township has not allocated funds in the annual budget to support non-municipal cemeteries.

## **Analysis:**

The Bereavement Authority of Ontario (BAO) seeks the assistance of municipalities to proactively offer support and assume responsibility of cemeteries – community, family and volunteer run etc., by providing maintenance and materials and/or administrative assistance so that those cemeteries can continue to serve their communities without having to resort to complete abandonment and to locate / identify cemetery sites within the jurisdiction which are not currently licensed under the Funeral, Burial and Cremation Services Act (FBCSA).

An application to declare a cemetery abandoned may be made to a judge of the Superior Court of Justice, if the owner of the cemetery cannot be found or is unknown; or is unable to maintain it; or is not a licensed operator and there is no licensed operator.

The municipality is responsible for the cost of an abandonment application, unless the cemetery is not declared to be abandoned by the judge, in which case the owner of the cemetery is responsible for the cost of the application. The municipality is responsible for the cost of a survey of the land involved and the maintenance of the cemetery during the application process.

A judge to whom an application is made, upon being satisfied that there is a basis for the application, shall, by order, declare the cemetery to be abandoned. Upon declaration that a cemetery is abandoned, the judge will convey the cemetery and the land on which the cemetery is situated to the municipality. Once the declaration / order is registered in the appropriate land registry office, the municipality becomes the owner of the cemetery with all the rights and obligations with respect to the cemetery, and the related assets, trust funds and trust accounts that the previous owner had. The process for the transfer of the site to the Municipality also includes the transfer of any Care and Maintenance Funds or Accounts that the cemetery operator may have had.

## **Financial Implications:**

Should the Cemetery Grant Policy be approved, Council may wish to consider providing funds from the General Reserve Account and/or in-kind services to provide support for non-municipal cemeteries in the 2025 year upon a request being received.
