#### Call to Order and Welcome

Mayor Amyotte called the meeting to order at 9:30 a.m., welcomed everyone and informed those in attendance that the meeting will be recorded and uploaded to the Township YouTube Channel for public viewing.

# Adoption of the Agenda

#### **Introduction of New Staff**

Mayor Amyotte introduced Colleen Lockhart, Fire Prevention Inspector. She acknowledged her certifications and experience and welcomed her to the Township.

#### **Update from Fire Chief Lambe**

Chief Lambe informed Council that North Kawartha is in a total fire ban including fireworks. He stressed the importance of residents complying with the fire ban. Chief Lambe is receiving updates from the Ministry of Natural Resources and Forestry regarding the Haliburton 018 fire as well as updates from Trent Lakes Fire Chief regarding the fire in that area. North Kawartha Fire Department has not received any requests for assistance. Callers may call 911 to report illegal burning.

Mayor Amyotte has spoken to Tyler Speck, Ontario Parks, and a total fire ban is being actively enforced.

# **Statutory Public Meeting**

The Statutory Public meeting was declared open to hear a zone amendment application.

Chair Amyotte declared the hearing open and explained that this was an opportunity for the public to provide written or verbal comments on the applications. The Planning Act has removed the right of public appeals on Council decisions. Only the applicant, public agencies and specified persons may appeal within the 20-day appeal period from the date of the notice of decision.

# **Zone Amendment Application #ZA-04-25 (McKellar)**

Laura Stone, Planning Consultant, identified the lands and explained the purpose and effect of the application. The application is a condition of consent. Approval of the application was recommended by staff.

#### **Submissions**

Aditya Srinivas, Planner, EcoVue Consulting Services, and Agent was present to answer questions.

Allan Duncan asked if there were plans to expand Spence Road through Doc Evans Road.

Ms. Stone responded that a recommendation was made in October, 2024 to ensure the right-of-way continues unencumbered so there is no impact to the use or travelability of Spence Road. It is not part of the application.
