# **Report to Council**

Subject: Commercial Wood Chipper

## **Recommendation:**

That Council directs staff to purchase a Vermeer BC1200XL commercial wood chipper with winch kit and Optional Vermeer Canada Promise Program to manage roadside trees and brush.

## Background:

The Public Works Department currently owns a Morbark six (6) inch Wood Chipper. This Chipper is too small and slow for the quantity and size of trees and brush that we experienced during the Derecho in 2022 and now the Ice Storm of 2025. The unit also does not have a hydraulic winch and is not recommended for one as it is too small to handle any material above six (6) inches in diameter.

## Analysis:

We are recommending purchasing a Vermeer BC1200XL Wood Chipper. This unit has the capabilities to manage brush and trees up to thirteen (13) inches in diameter and will be much quicker than our current model. This will allow the Public Works Department to handle larger trees with the capability to winch trees into the Chipper feed without a secondary machine trailing the unit. The Chipper is portable and can be moved easily to the jobsite and will increase our efficiency when dealing with these major natural occurrences as well as routine brushing operations. This will allow other equipment to perform tasks while the Chipper is in use. This unit could also be used at the Municipal Transfer stations for managing brush when not in use by the Public Works Department.

#### **Financial Implications:**

The quotes that are provided in the spreadsheet below reflect costs through the Canoe Procurement Program.

This item was not included in the 2025 Capital Budget so funds would come from Future Capital Reserve. If MMAH (Ministry of Municipal Affairs and Housing) activates the MDRA (Municipal Disaster Recovery Assistance) program we would include this item in our claim submissions.
