**The Purpose and Effect** of Minor Variance application #A-09-25 is to facilitate the construction of a bunkhouse to the northeast of the existing dwelling. The application seeks a variance to Section 6.2 (d) to permit the bunkhouse to have a maximum area of 52 square metres (560 square feet) whereas the maximum area for a bunkhouse is otherwise limited to 37 square metres (400 square feet).
