Minor Variance A – 11 – 25 (Birtley)

Laura Stone, Planning Consultant, identified the lands and explained the purpose and effect of the application. Approval of the application was recommended.

That Committee approve Minor Variance Application A – 11 - 25, (Birtley), Part of Lot 16, Concession 10, Chandos Ward, 24 Hemlock Point Road, Roll # 1536-010-101-06600 to permit the increase in lot coverage for accessory uses, to allow for a bunkhouse use of 53.3 square metres and to permit an accessory use (garage with loft bunkhouse) with a height of 7.54 metres to be located 2.87 metres from the rear yard as it is minor in nature, appropriate and desirable, conforms with the intent of the County of Peterborough Official Plan and Township Zoning Bylaw and the Provincial Planning Statement. Carried.

Minor Variance A – 13 – 23 (Gray)

Mayor Amyotte explained that this application came before Committee a few years ago.

John Ewart, Municipal Solicitor, attended the meeting electronically. He explained that Minor Variance application A-13-23 is before Committee as a result of a motion by Tim Gray. The decision for the application when rendered at the time addressed only two of the variances of the four requested and essentially there was a non-decision on two of the variances. The purpose is to move the matter to a fresh hearing if Committee is inclined. No new application is required but a new hearing will need to be held.

Richard Taylor, Solicitor for Mr. Gray, was not in attendance.

Peter Gray and Tim Gray attended electronically. Peter Gray indicated that they understand this is the correct way forward and appreciate the opportunity for a hearing at the October 7, 2025, meeting.
