

The Corporation of the Township of North Kawartha

By-Law 2015-142

Being a by-law of the Corporation of the Township of North Kawartha to designate the Mayor as Head and to delegate to the Clerk the powers and duties of the Head for the purposes of the Municipal Freedom of Information and Protection of Privacy Act (MFIPPA) and to repeal By-Law #34/13.

Whereas section 3(1) of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c. M.56 (the "Act") provides that the Council of a municipal corporation may by by-law designate from among its members an individual or a committee of the Council to act as head of the Municipal Corporation for the purposes of the Act;

And whereas Section 3(3) of the Act provides that if no person is designated as head, the head shall be the Council;

And whereas the Council deems it necessary and expedient to designate a head for the purposes of the Act;

And whereas Section 2 (1) of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c. M.56 (the "Act") interprets "institution" (b) to include a police services board and public library board;

And whereas Section 3 (1) (the "Act") provides that the members elected or appointed to the board, commission or other body that is an institution other than a municipality may designate in writing from among themselves an individual or a committee of the body to act as head of the institution for the purposes of this Act;

And whereas the North Kawartha Police Services Board has designated the Chair as head for the purposes of the Act;

And Whereas the North Kawartha Public Library Board has designated the CEO as head for the purposes of the Act;

And whereas Section 3 (3) (b) of the "Act" provides that if no person is designated as head, the head shall be the members elected or appointed to the board;

And whereas Section 49 (1) (the "Act") provides that a head may in writing delegate a power or duty granted or vested in the head to an officer or officers of the institution or another institution subject to such limitations, restrictions, conditions and requirements as the head may set out in the delegation;

Now Therefore the Council of the Corporation of the Township of North Kawartha in Session duly assembled enacts as follows, that:


1. For the purposes of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c. M.56 (the "Act"), the Mayor be designated as head.
2. For the purposes of the Act, the Mayor's powers and duties under the Act be delegated to the Clerk.
3. For the purposes of the Act, the North Kawartha Police Services Board Chair's powers and duties under the Act be delegated to the Clerk.
4. For the purposes of the Act, the North Kawartha Library CEO's powers and duties under the Act be delegated to the Clerk.

5. That By-Law 2015-018 is hereby repealed and all other by-laws contrary to this by-law of the Municipality of North Kawartha are hereby repealed in their entirety.
6. This By-law shall come into force and effect on the date of final passing.

Read a first, second and third time and passed in open council on the 17th day of November, 2015.
